

RIVERCITY CASINO

Lemay, South St. Louis County

Location

Pinnacle Entertainment's new entertainment district in south St. Louis County straddles the frontier between the County and the City of St. Louis. Overlooking the Mississippi River, the site rests just south of the confluence of the Mighty Mississippi and the River des Peres. In 1700, French Jesuits established a mission in this area, which is now one of the most densely populated parts of the St. Louis Metropolitan Area, the nation's 18th largest, with more than 2.6 million residents.

Economic Impact

Pinnacle has invested approximately \$380 million into south St. Louis County (consistent with earlier cost projections), excluding operating cash, non-cash rent accruals and capitalized interest. Highlights include:

- Creation of approximately 600 union construction jobs, more than 1,200 permanent jobs and hundreds of ancillary service jobs;
- Construction of a new public roadway – **River City Casino Boulevard** - to provide primary access to the site and open up new areas of County and City to needed development;
 - Pinnacle invested more than \$23.8 million in the nearly 1.5-mile-long roadway, which provides a vital east-west link between the I-55 and South Broadway corridors;
 - New signal-controlled intersections at Lemay Ferry Road, South Broadway and on to the River City Casino site create more efficient traffic flow in the Lemay area;
 - New sections of the roadway are built above the 100-year flood levels.
- Contribution of \$5.1 million for community and recreation facilities;
- Environmental clean-up of long-abandoned former National Lead site;
- Among the largest private investments in St. Louis;
- Anchor facility will spur additional development on neighboring sites.

Property Size

Pinnacle's 250,000-square-foot project sits on approximately 56 acres with a gaming floor of approximately 90,000- square- feet.

Opening Date

River City Casino opened to the public on March 4, 2010.

 - **Burger Brothers** – a spin on the classic burger joint serving mouthwatering burgers prepared with the "Handmade Burger Brothers Blend." The casual, 50-seat dining area and quick counter service create an ideal spot for "grab-'n'-go" grub;
 - **Judy's Velvet Lounge** – a 75-seat entertainment lounge featuring live music, bar-top slots, and high-definition, flat-screen TVs;
 - **BarCentral** – Located at the heart of the casino floor, hot bar-top slots and cold drinks mixed and served by the Ladies and Gents of River City create a lively 40-seat social centerpiece;
 - **Peet's Coffee & Tea** - a truly distinctive coffee experience featuring handcrafted beverages and the freshest, artisan-roasted whole-bean coffee available; plus, decadent baked goods, muffins, Danish, croissants and other savory items.
- Retail shopping at **ETC** – a selection of exclusive River City logo apparel, sunglasses, seasonal gifts, snacks and sundries;
- Parking for more than 3,000 vehicles.
